Based on the recognition accorded by the National Council of Teacher Education, Bangalore and the recommendations of the University Inspection Committee, the University has accorded approval for grant of provisional affiliation Jonah College of Teacher Education, Aitipamula, Kattangur, Nalgonda Dist. for the academic year 2022-23 to offer B.Ed. Course with an intake of 100, subject to the fulfillment of the following conditions and general rules of affiliation.

CONDITIONS:

1. Computer lab with internet facility to be provided.
2. Laboratories have to be upgraded and updated as per the curriculum.
3. Library books for reference and journals worth of Rs. 50,000/- to be procured.
4. No internet facility
5. Teaching needs improvement.
6. To appoint teaching staff through duly constituted selection committee as per NCTE 2014 norms representing all Methodologies and obtain the Renewal / Approval from the Registrar, MGU for the existing / New staff including Principal at the beginning of the academic year 2022-23.
7. The details of approved lecturers along with their photographs are to be uploaded to University website www.mguniversity.in and a hard copy to be submitted to the University.
8. Salaries need to be paid by cheque or Online transfer.
9. CC TV should be installed.
10. Anti-ragging committee need to be constituted and should be displayed properly in the college premises.
11. Access road need to be developed immediately.
12. Three Governing Body meetings are conducted in an academic year associating University nominee and the resolutions are to be submitted through University nominee.
13. Teaching diaries and student attendance registers are to be maintained properly.
14. The Purchase of guides or study material in any form cannot be considered as part of the books purchase for the Library.

The Management is directed to submit the compliance Report on the fulfillment of the above conditions **within one week** with documentary evidence wherever necessary, through Governing Body member nominated by the University in the following prescribed proforma.

GENERAL CONDITIONS TO BE FULFILLED BY ALL COLLEGES:

1. That they should appoint teaching staff through duly constituted selection committee as per NCTE 2014 norms, associating the University Nominee on the Selection Committee and Subject Expert representing all Methodologies and obtain the Renewal/Approval from the Registrar MGU for the Existing / New staff at the beginning of the academic year whenever required.
2. To provide spacious rooms for classes and laboratories and separate toilets for boys and girls as suggested by the Inspection Committee.
3. Consolidated attendance statement is to be prepared every year and submit to the University.
4. It is made clear to your college that if the above conditions are not fulfilled by your college within the stipulated time, your college will be disaffiliated under intimation to NCTE/State Government.
5. To appoint a qualified librarian
6. Attendance registers and teaching diaries are to be maintained properly. Attendance to be marked in the class room only.
7. College should follow MGU almanac strictly.






